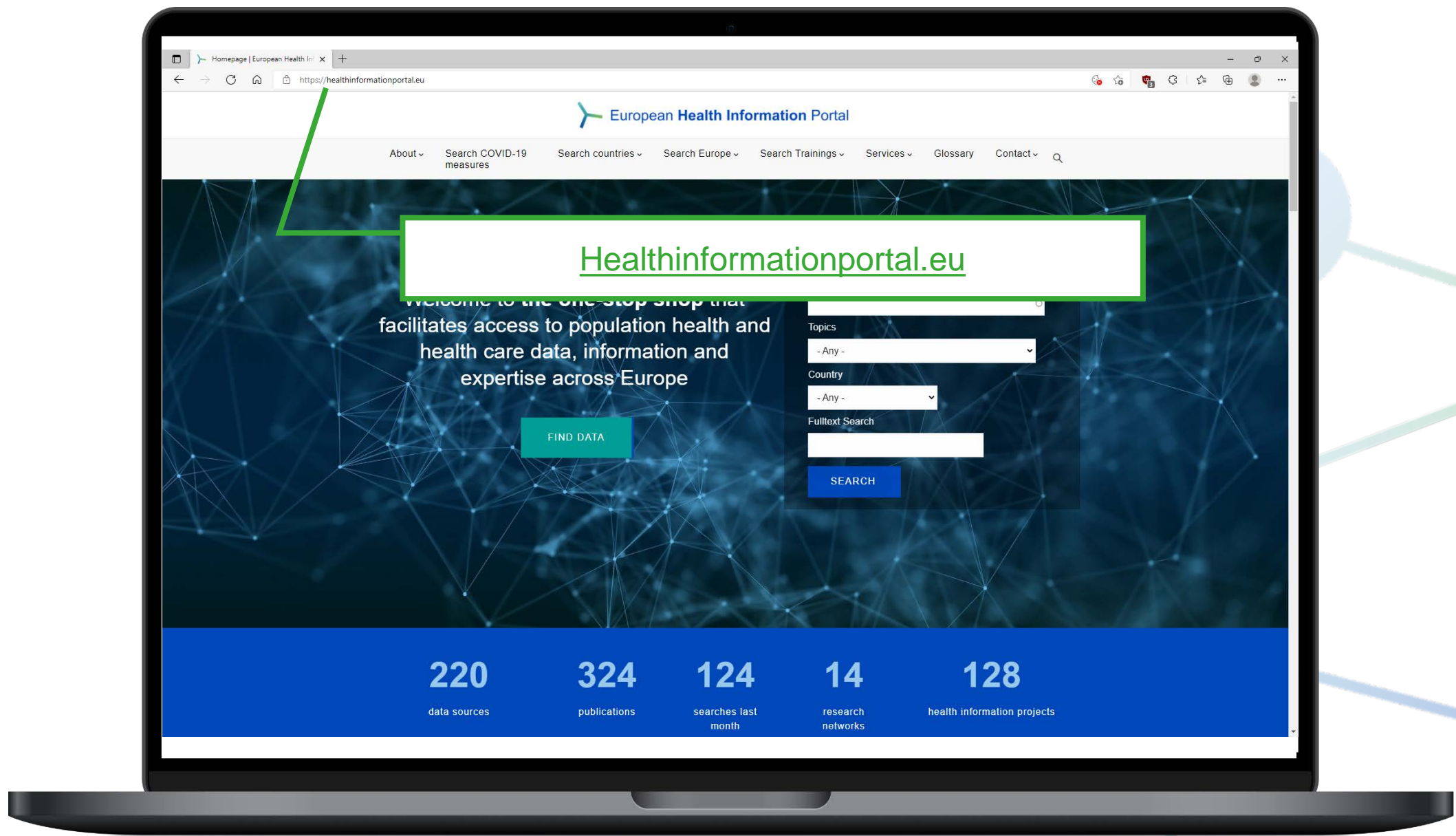

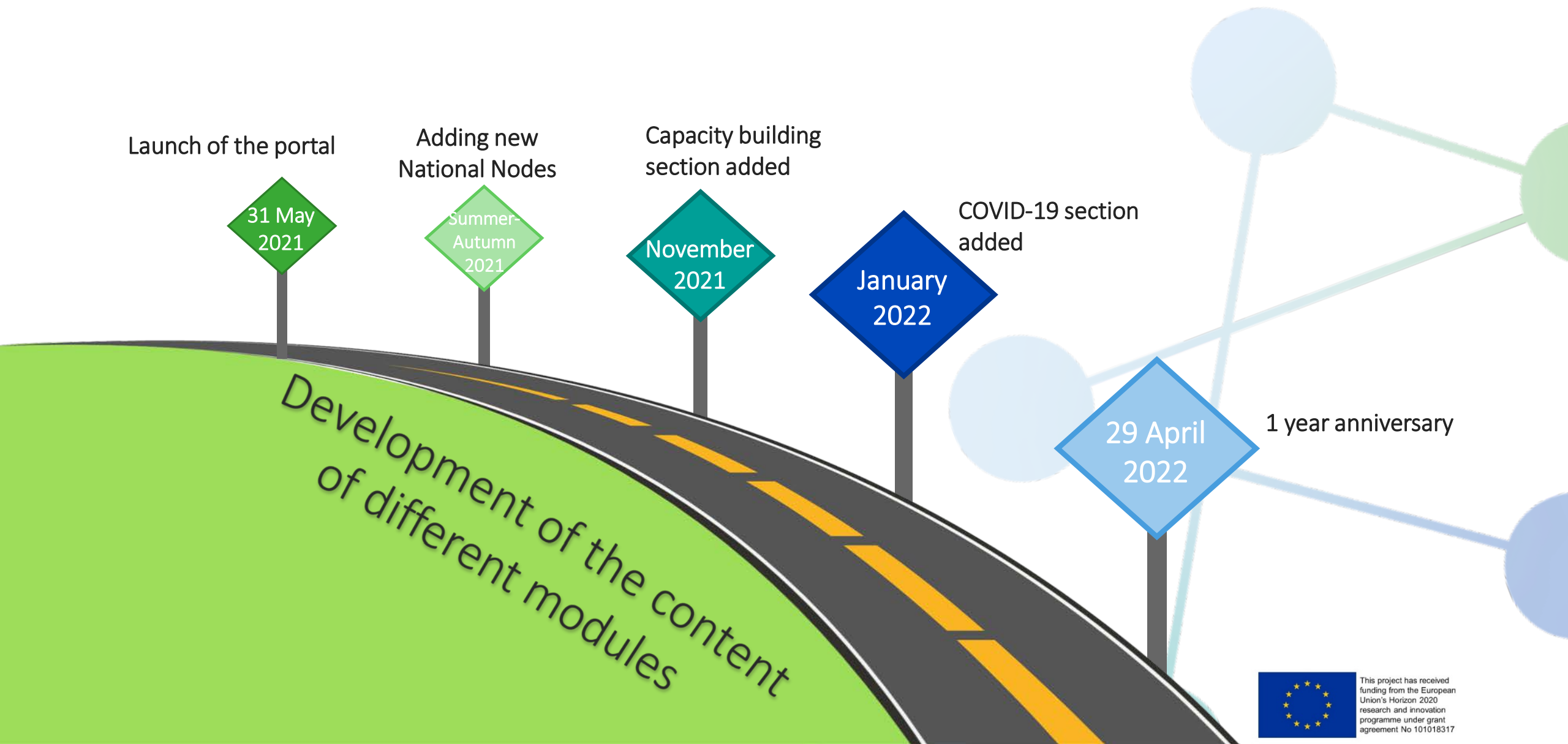


Health information portal

- Provides a centralized, one-stop-shop, for researchers and policy makers to find health information
- Enhances the secondary use of health information
- Uses metadata standards (DDI and Dublin Core) for its catalogues → supports FAIR principles and interoperability

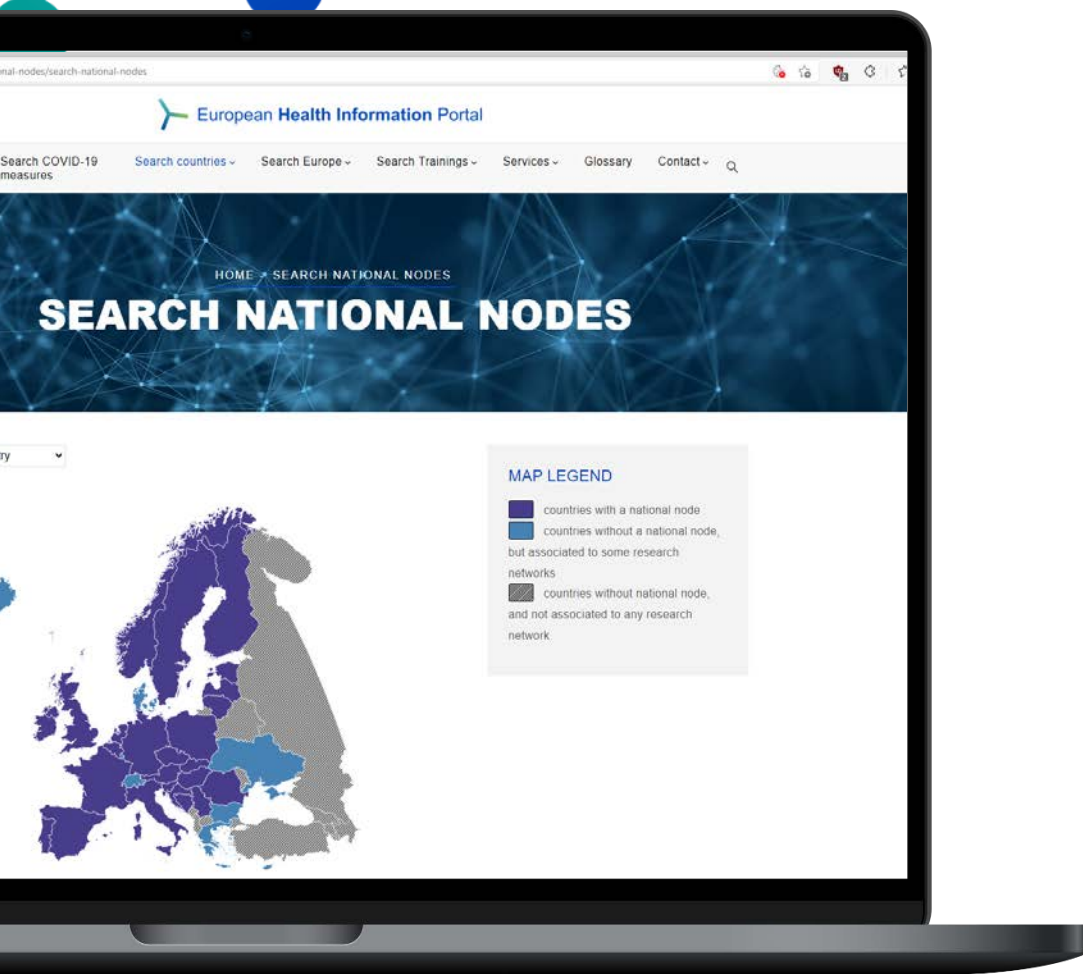

National Nodes (NN)



- The NN is an organisational entity, often linked to a core group of national institutions or governmental units that function as a national liaison and brings together relevant national stakeholders in a systematic way
- National Nodes are an essential partners for the development of the HIP
- Latest work on NNs
 - New NNs added
 - New information on data sources, publication etc. added for existing NNs

Health Information (HI) sources

NEW

Extended metadata template for HI sources available on the Portal

- New structure and more detailed information available for the HI sources
 - **Overview** incl. name, type of information, description, governance and legal framework, funding, keywords
 - **Demographics** incl. geographical coverage, target population (age, sex), size of the dataset
 - **Dataset** incl. data collection period, language, updating frequency, availability of personal identification, level of aggregation, record linkage possibility
 - **Access** incl. terms of data access
 - **Contact** incl. information on data owner and contact information

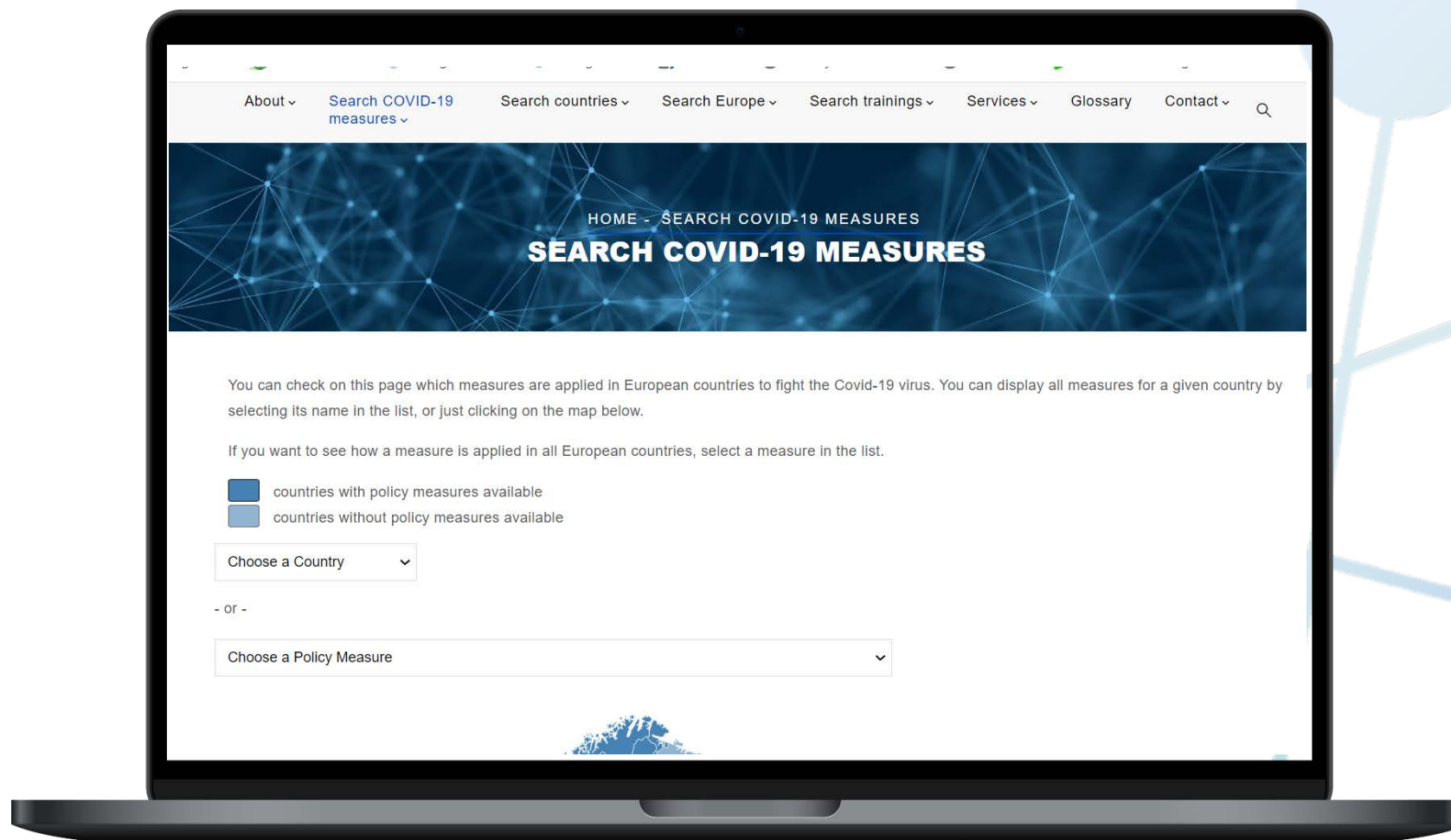

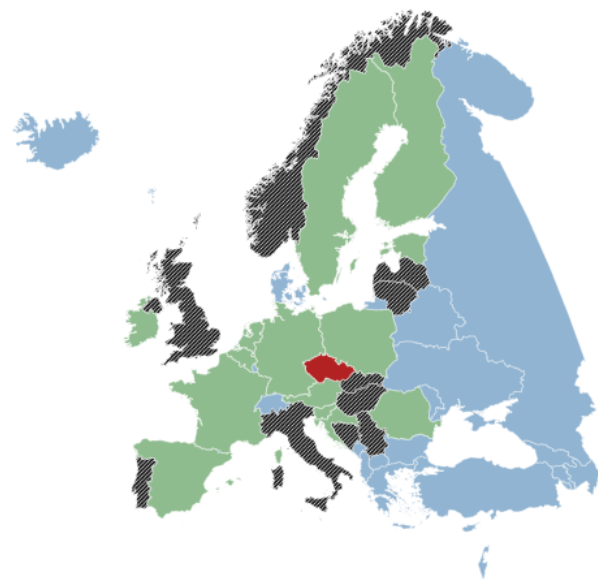

Rapid Exchange Forum



Within PHIRI, the **Population Health Information Research Infrastructure**, a **Rapid Exchange Forum (REF)** on **COVID-19** activities is organized every two **weeks**. In this one hour meeting, the participants belonging to European public health institutes, Ministry of Health or Research and universities answer and discuss the experiences in their own countries on specific questions related to COVID-19 measures submitted until 24 hours prior the start of the meeting. This allows a **rapid exchange of information across countries** to compare e.g. vaccination priorities, tests usage, mortality indicators and measures adopted for the containment of the pandemic and learn from other countries' experiences.

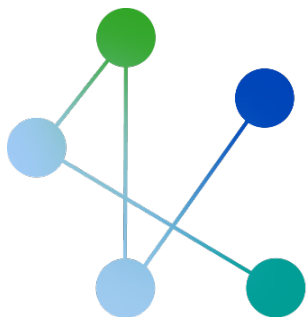
